**Risk Disclosure Statements 風險披露聲明**

The Guidelines for Reducing and Mitigating Hacking Risks Associated with Internet Trading published by the Securities and Futures Commission require clients be notified promptly after certain client activities have taken place in their internet trading accounts. Online Trade Execution Notification is a monitoring measure implemented by the Guidelines. By receiving promptly notification on trade execution, clients can detect all potential unauthorized transactions in a timely manner and take measures to reduce or mitigate hacking risks associated with internet trading. If clients choose to opt-out from online trade execution notification, they may fail to know or detect their accounts being hacked, unauthorized transactions or abnormal activities in time. Clients acknowledges, understands and wholly be responsible for any disputes, losses, liabilities and risks involved in opt-out from online trade execution notification.

證券及期貨事務監察委員會發表的《降低及紓減與互聯網交易相關的黑客入侵風險指引》要求在客戶的互聯網交易帳戶內出現某些客戶活動後，立即通知有關客戶。互聯網交易執行通知是根據《降低及紓減與互聯網交易相關的黑客入侵風險指引》而實行的其中一項監察措施，通過及時收取執行交易通知，客戶可儘早偵測所有潛在的未經授權交易，從而採取措施以降低或紓減與互聯網交易相關的黑客入侵風險。如果客戶選擇不收取互聯網執行交易通知，客戶可能未能及時知道或發現帳戶被黑客入侵、未經授權的交易或異常活動。客戶確認、明白及願意承擔一切可能因此引致之任何爭議、損失、責任及風險。
